Assist with maintaining order and controlling of the pool users with particular attention to safety and proper use of the facilities.

Ensure to effect a rescue including, but not limited to administer first aid and resuscitation when necessary.

Ensure effective maintenance and cleaning of all swimming pool facilities including toilets and change rooms, as well as ground maintenance and general cleaning to a high standard and in accordance with relevant regulations, policies and procedures.

Maintain current qualifications as a pool lifeguard.

Assist in operations of the Spray Park as directed.

Work effectively as part of team to achieve excellent customer service.
